Capitol Body Shop, Inc. provides a **Lifetime Limited Warranty** on work performed during the repair of your vehicle. This Lifetime Limited Warranty is valid only for as long as you own the vehicle stated herein, and is not transferable, being granted exclusively to the person whose name appears herein and on the original work order. This is a labor only, four part Warranty, and stipulations pertaining to each part are stated hereafter.

1. Metalwork: A Lifetime Limited Warranty is provided for all metalwork, to include welding and the application of materials utilized in making collision repairs against cracking, flaking, pitting or deterioration, excluding rust repairs, on any metalwork warranted.

2. Painting, Stripes and Decals: A Lifetime Limited Warranty is provided for all painting-related priming and painting work against solvent blistering, peeling, hazing, and excessive loss of pigmentation. Impact chips to the paint, surface scratches, chemical spotting or staining and rust repair are excluded. A Lifetime Limited Warranty is provided on the application and adhesion of decorative stripes and decals, excluding those defects which are caused by extreme environmental conditions in which the vehicle may be exposed. The shop will re-prime, re-paint, re-stripe or re-decal the specific section or sections of the vehicle warranted.

3. Mechanical Repairs: A Lifetime Limited Warranty is provided for mechanical repairs pertaining directly to original collision damage.

4. Parts: Warranty on new, aftermarket, used or remanufactured parts replaced in making collision repairs shall be provided according to the warranty limitations of the manufacturer or supplier of said parts. Shop warranty on replacement parts does not exceed manufacturer or supplier warranty.

The shop will repair, repaint, or replace any items in sections 1-4, when claim is made while the present owner stated herein owns the vehicle, unless caused by or damaged resulting from unreasonable use, maintenance, or care of the vehicle. This Warranty shall be null and void if the repair is altered, adjusted or tampered with by any person not authorized by Capitol Body Shop, Inc., the Warranty Grantor.

Specifically Excluded: Incidental costs, such as towing fees, car rental charges, travel expenses or assemblies and components which are not specifically covered by this Warranty, deterioration to wearable parts due to normal use or unreasonable use or maintenance, or consequential damages such as damage to other assemblies and components resulting from a defective part or installation of such part installed or repaired during the repair.

Customer's Obligations: In order to obtain the benefits of this Lifetime Limited Warranty, the vehicle owner shall:

1. Notify the warrantor of any suspected warranty issue(s) at the phone number listed herein during normal business hours or at 601-936-6700 after hours.
2. Present the owner's copy of this Warranty document to the warrantor before requesting warranted repairs or parts, and
3. At the discretion of the warrantor have any warranted repair, adjustment, or inspection made only at the premises of the warrantor during normal business hours.
